

Options Update

4 April 2011, Melbourne, Australia: Benitec Limited (ASX: BLT) wishes to confirm recent changes in its options.

- A further 200,000 ESOP options with an exercise price of \$0.0224 and an expiry date of 4 September 2011 have been exercised by an ex-employee (refer to the attached Appendix 3B. The remaining 2,580,000 options in this series have now expired following the departure of the employee.
- 3,000,000 ESOP options with an exercise price of \$0.115 and an expiry date of 21 February 2013 have also expired following the departure of the employee.
- 56,081,915 listed options (ASX Code: BLTOA) expired on 4 April 2011.
